## **COVID-19 Grants Target Domestic Violence, Family Services**

United Way Announces New Awards to 7 Agencies Totaling \$45,000

REDDING, CA (May 1, 2020) – United Way of Northern California (UWNC) today announced a new round of grants to agencies providing vital services in the wake of the COVID-19 emergency. Seven North State agencies will receive a total of \$45,000, bringing the total UWNC grant outlay to \$142,000 since the onset of the crisis.

## Awardees include:

- Boys and Girls Club of Greater Shasta, serving Siskiyou County, \$5,000 to subsidize membership fees for low-income families. This grant is supported by The Statewide Listos California for All Emergency Preparedness campaign
- Boys and Girls Clubs of the North Valley, serving Butte and Glenn counties, \$5,000 for food and grocery cards for families
- Chico Meals on Wheels, serving Butte County, \$10,000 to support food and delivery services
- Hornbrook Community Center, serving Siskiyou County, \$5,000 for expenses associated with food delivery to vulnerable populations. This grant is supported by The Statewide Listos California for All Emergency Preparedness campaign
- Lassen Family Services, serving Lassen County, \$7,500 for domestic violence shelter operations in anticipation of increased need due to the crisis
- Mercy Foundation North, serving Shasta County, \$7,500 to support the Food Bank at Dignity Health Connected Living
- Training, Employment & Community Help Inc., serving Plumas and Siskiyou counties, \$5,000 to provide five lunches per week to homebound seniors
